John Cyprian Stevens (pictured right), a Portland civil engineer for whom the J.C. Stevens Legacy Society is named, was instrumental in founding OMSI more than 75 years ago. Championing a local effort to establish a permanent space to showcase Oregon's rich natural resources and dreaming of a hands-on museum of science and technology, Stevens became one of OMSI's strongest advocates and served as both President and Board Member throughout the years. J.C. Stevens helped found OMSI in 1944 and, within a decade, the museum had added a planetarium and was attracting thousands of visitors each year as a non-profit 501(c)(3) organization*. Today, OMSI serves more than 1 million visitors annually and is ranked as one of the top science centers in the United States with an international reputation for its innovative exhibits and educational programs.
